## The following steps are necessary to obtain a Sportfishing Charter Boat Operator permit from the lllinois Department of Natural Resources (IDNR).

a. You must have a current and valid U.S. Coast Guard license. If you do not have one, go to the following website for information for your merchant mariner credential: www.uscg.mi//nmc. Before applying for your USCG license you must have a TWIC (Transportation Worker Identification Credential). You can access this link on the USCG website or go directly to https://www.tsa.gov/stakeholders/transportation-worker-identification-credentialtwic\�\�.

Please note the requirements for a mariner's license require you to submit the results of a current physical examination and results from drug testing done by a certified medical review officer (MRO) in good standing. These MROs can be found on the following websites: (1) www.mrocc.com (All MROs are in good standing.) and (2) www.aamro.com (MROs with the purple icon, "In Good Standing," are in good standing).

If you have any questions regarding the USCG application process, you can call 888-427-5662. Completed applications are accepted electronically, by mail, fax, or in person at any of the 17 local Coast Guard National Maritime Centers throughout the United States. The two nearest offices to lllinois residents are in St. Louis, Missouri and Toledo, Ohio.
b. If you own a vessel that will be used for chartering purposes, the vessel must have a current registration completed with your State. For Illinois residents, go to the IDNR website at www.dnr.illinois.gov/recreation/boating/Pages/default.aspx or call our Watercraft registration office at (800) 382-1696.
c. A Passenger Boat License from IDNR is required for each vessel that will be used for chartering purposes on Lake Michigan. This license must be renewed each year prior to obtaining a Lake Michigan Charter Operator Permit. The Passenger Boat License costs $\$ 50.00$. For additional information and application forms, go to: www.dnr.illinois.gov/recreation/boating/Pages/PassengerRentalBoatLicense.aspx or call (800) 382-1696. A U.S. Coast Guard Certificate of Inspection must be completed and sent along with the Passenger Boat License application. The Marine Inspection Reports (either for 6 passengers or less or for over 6 passengers) can also be found online at the website link above.
d. A Lake Michigan Charter Boat Operator Permit can be obtained by selecting the following link, Lake Michigan Sportfishing Charter Operator Permit Application, or by contacting the IDNR Lake Michigan Program office at (847) 294-4134. Print and fill out the application as instructed. All of steps (a) through (c) listed above must be completed and finalized before applying for this permit. The Passenger Boat License must be valid through the entirety of the operating year (current year). We will not issue an Operator's Permit if the Passenger Boat License for
the vessel you will be operating expires in the current calendar year.
An Operator's Permit is valid until December $31^{\text {st }}$ of the current year. It is issued without fee to Illinois residents. Nonresident fees are as follows:

Indiana: \$100.00
Michigan: $\$ 100.00$
Wisconsin: \$400.00
Fees for nonresidents in a state other than that listed above can be determined by contacting the Lake Michigan Program office.

After obtaining an operator's permit, persons operating sport fishing charter boats in the Illinois waters of Lake Michigan must submit daily catch reports to the Lake Michigan Program on forms furnished and in the manner prescribed by the Lake Michigan Program. All daily catch reports for a given month must be submitted, on or before the $15^{\text {th }}$ day of the following month. Charter boat operators who fail to comply shall be subject to penalties as provided in Section 20-35 of the Illinois Fish and Aquatic Life Code and noncompliance may be grounds for denial of future charter boat permits.

e. If an operator will be using one the harbors in the City of Chicago, a City of Chicago Commercial Vessel Owners Permit must be completed. The fee is $\$ 75.00$. For permit information go to www.CityofChicago.org/city/en/depts/bacp/supp.info/water taxis tourboats com mercialpassengervessels.html or call the City of Chicago Department of Business Affairs and Consumer Protection at (312) 746-4200. Additional fees and requirements for operators using Chicago harbors may apply. f. In addition for those operators who will be using Chicago harbors, a \$1,000,000.00 Liability Insurance naming Chicago Park District and Westrec Marina Management as Additionally Insured is required. Contact Westrec at (312) 742-8520 for further information.
g. Vessels that use MF/HF single side-band radios, satellite communications, or telegraph must be licensed with the FCC (Federal Communications Commission). The license is for the boat (not the operator). The license cost can be determined by calling the FCC office at (888) 225-5322 or visiting the FCC website at www.fcc.gov.
